

Sir,

I, Smt. Jeevitha Rajasekhar, W/o. Dr.Rajasekhar, Age 51 years, Occ.: Movie Artist,
R/o. Plot No.16, Road No.71, Jubilee Hills, Hyderabad, Telangana State, making the present
complaint as follows:-

I am a movie artist and my husband Dr.Rajasekhar is also a movie artist and we were
in the industry since so many years and having good image and reputation in the society. On
14.04.2018, one Telugu News channel by name MAHAA News (electronic Media), in a live
debate regarding casting couch in the Telugu film industry, unnecessarily dragged me and
my husband Dr.Rajasekhar and levelled various false allegations against us without verifying
the facts and with a view to tarnish our image and reputation. The allegations so levelled in
the said debate conducted by the Mahaa News anchored by a person popularly known as
"MAHAA NEWS MURTHY" are blatant and baseless allegations certainly undermined our
fame and reputation in the society which is nothing but intentional insult committed with an
intention to provoke me. The entire discussion that was taken place between
anchor "MAHAA NEWS MURTHY and another Lady called POW Sandhya was uttered and
intended to insult my modesty which is also nothing but intruding into my right to privacy. I
am herewith enclosing C.D of the said debate held in the studio of Mahaa News aired on
14.04.2018 for the kind perusal of this authority for taking necessary steps at your end. In
the said debate, anchor of Mahaa News called P.O.W activist Sandya and invited her over




phone on the issue of casting couch to which the said Sandya spoke on air, falsely alleged that I had threatened a girl staying at working womens' hostel, at ameerpeta with abusive language and shouted on her and insisted her to sleep with my husband and she further alleged that I am encouraging prostitution. The anchor of Mahaa News, instead of insisting for proof of such allegations levelled by women activist Sandya, strangely allowed her to speak non sense with an evil design to cause damage to me and to my husbands' reputation. The said allegations went on air and incidentally I had to watch the debate which caused mental agony, stress, trauma, tension and lot of humiliation to me and to my family and that apart the allegations lowered my moral character. I understood that since I was appointed as a member in the cash committee, the said Mahaa News channel tried to tarnish my image in the various circles of the society for the reasons best known to them.

Hence, I request your kind authority to register this complaint and enquire in to the matter and take initiate appropriate and suitable action against the management of Mahaa News, its anchor "MAHAA NEWS MURTHY and the women activist POW Sandhya for intentional insult intended to outrage my modesty by making absolute false and defamatory statements against me and my husband immediately as per the provisions of the appropriate sections of Indian Penal Code or as per law.
